## BULLOCH COUNTY BOARD OF TAX ASSESSORS

### INSTRUCTIONS FOR REGISTERING A MOBILE HOME IN BULLOCH COUNTY

Persons wishing to set up a mobile home (MH) in a new location within Bulloch County (in either unincorporated or incorporated areas), must properly register the mobile home with the county. This process can be completed at the Bulloch County North Main Annex at 113 North Main St. in Statesboro which is open from 8am-5pm Mon-Fri. The registration process can generally be broken down into 4 steps:

#### 1. Establishing ownership of the mobile home:

This step is done at the Tax Commissioner's Office. The owner must have valid proof of ownership of the MH in the form of a title, or apply for new title. The Tax Commissioner's office handles all title transfers and can provide the owner with the proper paperwork for registering the MH with the county. Please note that all taxes must be current on the MH before title transfers can be processed.

#### 2. Notifying 911 Addressing:

This step is done at the Tax Assessor's Office. The MH owner will be provided with a 911 address letter which establishes the physical location of the MH. This step insures that the MH location has been documented and that emergency personnel can locate the residence if it is ever necessary.

#### 3. Registration with Tax Assessor's Office:

This step is also done at the Tax Assessor's Office. The MH information including owner, size, location, etc will be recorded to insure that the MH is properly accounted for on the tax digest and that tax bills are sent to the correct owner at the correct address. To complete this step you will need the ownership verification and 911 location information obtained in steps 1 and 2 above.

#### 4. Obtaining current mobile home decal:

Georgia law requires that all mobile homes display a current decal by April 1<sup>st</sup> each year. Upon registering a mobile home with the county using the steps above the owner will be provided with a current mobile home decal by the Tax Commissioner's office which should be affixed to the MH in a place that is visible to staff of the Tax Assessor's office which may do periodic visits to insure MH owners are in compliance with the decal requirement. Decals are issued annually at the time the tax bill is paid.
