### NECESSARY FIRE INSPECTIONS FOR NEW CONSTRUCTION

To schedule an inspection contact the Statesboro Fire Department at: (912)-764-3473

Commercial Hood System Light Test: Is a test to check the welds in a hood system

• Note: Fire Inspectors will need electrical connection for the test light.

**Visual/Hydrostatic Sprinkler Inspection:** Is an inspection to check for any deficiencies in the piping, bracing or hangers. A 200psi for 2 hour test will be performed at this time also

**Fire Rated Assembly Inspection:** Is an inspection to ensure fire code compliance of any fire rated walls, ceilings, floors or any other structural component that will be covered in a later phase of construction

• Note: This excludes drop down ceiling tiles

**80% Inspection:** Is an inspection of structural components that have been roughed-in but are still open for visual inspection

• Note: Structural components include the following: Fire walls, smoke barriers, vertical shafts, stairways, smoke stop, hazardous area separation, roofs, ceiling assemblies, corridors, non-rated assemblies, door widths, HVAC systems and electrical components

**100% Inspection:** Is an inspection of a building that is ready to be occupy and would qualify for a Certificate of Occupancy

• Note: This includes all required paperwork for Sprinkler Systems, Fire Alarm Systems and any other paperwork the inspector may require

All inspections must be performed prior to the issuance of a Certificate of Occupancy
