

City of Statesboro Opioid Settlement Reimbursement Grant Program

Introduction & Background:

The State of Georgia is actively responding to the opioid crisis, a public health emergency that has caused widespread harm across communities. As part of a national effort to address the impacts of opioid misuse, Georgia has entered into settlements resulting from litigation against major pharmaceutical companies and distributors. These funds are earmarked for initiatives aimed at curbing the opioid crisis and bolstering future abatement projects. Funds are dedicated to supporting a range of services related to Opioid Use Disorder (OUD), including prevention, treatment, harm reduction, and recovery support. These services target at-risk populations for OUD, individuals diagnosed with OUD, OUD with additional polysubstance use, OUD co-occurring mental illness. Opioid Settlement Funds may not be used for expenses or purposes that do not align with the allowable uses described as set forth in: Exhibit E Opioid Remediation Uses.

Program Overview:

The City of Statesboro is offering reimbursement grants up to \$15,000.00 for expenses related to opioid settlement funds as described in the list of opioid remediation uses from public or private, state and federally recognized nonprofit organizations, agencies, partnerships, or other interested parties for services, programs, or initiatives that has help to mitigate the impacts of the opioid epidemic on the residents and community with the municipal limits of Statesboro. Funds may not be used to reimburse past Medicaid expenses or any other expenses that would be subject to a federal claw back, recoupment, or similar mechanism.

Eligibility:

- 1. Completed reimbursement grant applications can be dropped off at City Hall, 50 East Main Street, Statesboro, GA between 8:30 am and 5:00 pm weekdays.
- 2. The businesses and organizations applying for funding must be registered to conduct business in the State of Georgia or registered as a non-profit organization in the State of Georgia and in good standing with local, state, and federal jurisdictions with respect to taxes, fees, utility payments, and other financial obligations. Supporting documentation must be submitted along with application: IRS Letter verifying non-profit status or business entity, current W-9, and proof of incurred eligible abatement expenses.
- 3. Funding requests must be \$15,000 or less and must be related to specific programming costs. Operating expenses (i.e. payroll, benefit costs, etc.) for the organization will be considered for funding. Funding is for reimbursement of incurred expenses only.
- 4. Reimbursement grants must benefit Statesboro residents.
- 5. Ineligible organizations are those that are in pending bankruptcy proceedings or that will file for such bankruptcy protections within six months of the date of the application for assistance.
- 6. Funding is provided once a year until funding is exhausted. All grant funds will be distributed via check made out in the organization's legal name according to the documentation provided.
- 7. Applications must go through a review process for consideration of an award.
