

# CITY OF STATESBORO CITY COUNCIL MINUTES April 03, 2012

A regular meeting of the Statesboro City Council was held on April 03, 2012 at 9:00 a.m. in the Council Chambers at City Hall. Present were Mayor Joe R. Brannen, Council Members: Will Britt, Tommy Blitch, John Riggs, Gary Lewis and Travis Chance. Also present were City Manager Frank Parker, City Clerk Sue Starling, City Attorney Alvin Leaphart, City Engineer Robert Cheshire, and Director of Community Development Mandi Cody.

#### **Other Business from City Council**

City Manager Frank Parker stated there would be a ribbon cutting at Great Dane at 10:00 a.m. this morning.

City Manager asked Council to consider a motion to approve the voting place for District 3,4 and 5 be moved to the Pittman Park Church and to authorize the Mayor to sign a resolution to make the changes and send to the Department of Justice (DOJ) for approval. Councilman Riggs made the motion, seconded by Councilman Chance to approve the voting place for District 3,4 and 5 be moved to the Pittman Park Church and to authorize the Mayor to sign a resolution to make the changes and send to the Department of Justice (DOJ) for approval. Councilman Britt, Blitch, Riggs, Lewis and Chance voted in favor of the motion. The motion carried by a 5-0 vote.

City Manager Frank Parker asked Council's approval to surplus the food bank building on Proctor Street also known as the "Grace Waters Cottage". Councilman Riggs made a motion, seconded by Mayor Pro Tem Will Britt to approve the surplus of the food bank on Proctor Street. Councilman Britt, Blitch, Riggs, Lewis and Chance voted in favor of the motion. The motion carried by a 5-0 vote.

City Manager Frank Parker asked Council to consider a request from Congressman Barrow for the use of an office in City Hall for 2 days a week. Council had no objections stating it should also be available to other officials who are interested.

City Engineer Robert Cheshire stated he would like to put together a stakeholders committee for the contract with Wolverton that would consist of members from GSU, DSDA as well as City employees and Councilmembers. Mayor Brannen stated he would look into appointing someone.

Director of Community Development Mandi Cody asked Council to extend the current moratorium for internet cafes' for another 6 months until a decision has been made on Senate Bill 431. Councilman Chance made a motion, seconded by Councilman Riggs to extend the moratorium for another 6 months. Councilman Britt, Blitch, Riggs, Lewis and Chance voted in favor of the motion. The motion carried by a 5-0 vote.

City Manager Frank Parker commended Public Safety Director Wendell Turner for his presentation at the Rotary Club.

Councilman Travis Chance recognized Director of Human Resource Jeff Grant for receiving the "20 Under 40" business leaders award.

Director of Community Development Mandi Cody stated the GSU grant application was submitted before the deadline.

Purchasing Agent Darren Prather stated the CRC grant specialist would be here today.

Director of Water Wastewater gave an update on Water Superintendent Danny Lively's condition.

Finance Director Cindy West stated the Budget Retreat would be on April 13, 2012 at 9:00 am.
