# A. City of Statesboro

Next City Council Meeting is on 3/7 at 9:00 am in Council Chambers. The event is open to the public and will also be available for viewing on the City's Facebook page. Applications for the Youth Council closed on 3/3 with 60 applicants from middle and high schools in the county. All 60 will be accepted and have been sent an email inviting them and a guardian to one of 2 information sessions. Applications for the Youth Commission and Tree Board opened today. Go to the City's social media accounts for more information. The Tree Board committee works with the Engineering and Public Works Departments to increase the number of trees in the city limits. This is an ordinance based charge. Youth Connect applications to open in the next few days. Plans are to hire 30 high school students to work for a 5 week period this summer.
