PRESENTATIONS

Development Authority of Bulloch County

Mr. Thompson's presentation covered the mission, structure, and history of the Development Authority. He also provided information on how important the Development Authority's role, along with that of the local governing bodies, is to creating a legacy of sustained growth. Mr. Thompson shared his experiences with various projects over the years. He discussed the creation of the Savannah Harbor-Interstate 16 Corridor Joint Development Authority with Bulloch, Bryan, Effingham, and Chatham Counties and how this collaboration between counties helped set the stage and draw for the new Hyundai Meta Plant. He stated that timing is important in economic development. Mr. Thompson provided information on the Hyundai plant and also shared potential impacts on Statesboro and Bulloch County.

Alan Gross, Business Recruiter GSU Business Innovation Group

Mr. Gross introduced himself and shared with the group what his position entails. He shared that his position was created out of a collaborative partnership between the City of Statesboro and Georgia Southern BIG. Mr. Gross extended his resources and offered to provide assistance to the Commission in gathering and analyzing data relating to small businesses.

Patrick Woock, Director, GSU Business Incubation

Mr. Woock introduced himself and shared with the group his responsibilities and vision as the Director of GSU Business Incubation. He stated that because of his experiences in both the academic and industry worlds, he is able to connect the two and provide valuable insight that will take what GSU's Business Innovation Group is doing to the next level. Mr. Woock offered his expertise and resources to the Commission.

Mr. Muldrew provided a brief overview of the DSDA. He shared how DSDA has grown and expanded	1
