8. Public Comments (General):

Malik Raymond addressed the Council regarding ongoing road construction on Springer Cove Road and Cypress Lake. He mentioned receiving conflicting information about when the construction would resume, with some sources indicating 2026 and others suggesting 2028. Mr. Raymond sought clarification to share with neighbors and residents in the area.

Mayor McCollar indicated that staff would connect with Mr. Raymond to provide the specific information he requested.

9. Other Business from City Council

Councilmember Shari Barr shared two announcements: The City of Statesboro, Tree Board, and KSBB will be recycling live Christmas trees this week. Trees can be dropped off at Public Works or at the Food World parking lot on Northside Drive West on Saturday, where citizens can also receive a free bare root seedling tree. Henry Clay, a longtime Tree Board member and environmental champion, had passed away the previous day. Barr expressed condolences to his family and honored his contributions to making Statesboro a greener, healthier city.

Barr later shared information about Shannon Killebrew Freeman, who recently passed away during the Christmas break. Freeman was recognized nationally for her work advocating for the rights of disabled and homebound individuals. A celebration of her life will be held at the Unitarian Universalist Fellowship on Saturday, January 17th at 11:00 AM.

10. City Managers Comments

City Manager Charles Penny welcomed everyone back after the holiday season and congratulated Mayor McCollar, Councilmember Johnson, and Councilmember Riggs on their elections. Mr. Penny announced that the Bulloch County NAACP had invited Council members to participate in the Martin Luther King Jr. Day Parade on January 19th at 11:00 AM. He noted that Mayor McCollar would serve as the grand marshal and emphasized that the parade time had changed from 2:00 PM in previous years to 11:00 AM this year.

For and in consideration of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, in hand paid by GEORGIA POWER COMPANY, a Georgia corporation (the "Company"), the receipt and sufficiency of which are hereby acknowledged, MAYOR AND CITY COUNCIL OF STATESBORO AND BOARD OF COMMISSIONERS OF ROADS AND REVENUES OF BULLOCH COUNTY, GEORGIA (the "Undersigned", which term shall include heirs, successors and/or assigns), whose mailing Address is, does hereby grant and convey to the Company, its successors and assigns, the right, privilege and easement to go in, upon, along, across, under and through the Property (as defined below) for the purposes described herein.

The "Property" is defined as that certain tract of land owned by the Undersigned at 601 AIRPORT BLVD, STATESBORO, GA 30461 (Tax Parcel ID No. 105 000004 000) in the 48, 1209 GMD (Georgia Militia District) of Bulloch County, Georgia.

The "Easement Area" is defined as any portion of the Property located (a) within fifteen (15) feet of the centerline of the overhead distribution line(s) as installed in the approximate location(s) shown on "Exhibit A" attached hereto and made a part hereof, (b) within ten (10) feet of the centerline of the underground distribution line(s) as installed in the approximate location(s) shown on "Exhibit A," and (c) within ten (10) feet from each side of any related above-ground equipment and facilities, including without limitation cubicles, transformers and service pedestals, as installed in the approximate location(s) shown in "Exhibit A."

The rights granted herein include and embrace the right of the Company to construct, operate, maintain, repair, renew and rebuild continuously upon and under the Easement Area its lines for transmitting electric current with poles, wires, transformers, service pedestals, anchors, guy wires and other necessary

apparatus, fixtures, and appliances; the right to attach communication facilities and related apparatus, fixtures, and appliances to said poles; the right to stretch communication or other lines within the Easement Area; the right to permit the attachment of the cables, lines, wires, apparatus, fixtures, and appliances of any other company or person to said poles for electrical, communication or other purposes; the right to assign this Easement in whole or in part; the right at all times to enter upon the Easement Area for the purpose of inspecting said lines and/or making repairs, renewals, alterations and extensions thereon, thereunder, thereto or therefrom; the right to cut, trim, remove, clear and keep clear of said overhead or underground lines, transformers, fixtures, and appliances all trees and other obstructions that may in the opinion of the Company now or hereafter in any way interfere or be likely to interfere with the proper maintenance and operation of said overhead or underground lines, transformers, fixtures, and appliances; the right of ingress and egress over the Property to and from the Easement Area; and the right to install and maintain electrical and communication lines and facilities to existing and future structure(s) within the Easement Area under the easement terms provided herein. Any timber cut on the Easement Area by or for the Company shall remain the property of the owner of said timber.

The Undersigned does not convey any land, but merely grants the rights, privileges and easements hereinbefore set out.

The Company shall not be liable for or bound by any statement, agreement or understanding not herein expressed.



RE: Bid for construction of STM-46 Little Lott's Tributary Stream Restoration Project, from East Grady Street to East Jones Ave.

Policy Issue: Purchasing

Recommendation: Staff recommends approval of the low bid and award of a contract in the amount of \$354,414.20 to Mid Georgia Property Enhancements LLC.

Background: As part of the City Stormwater Master Planning initiatives, the City applied for a Federal Clean Water Act, Section 319(h) grant, and was awarded \$381,715.00 for the purpose of stream restoration of Little Lott's Creek Tributary between East Grady Street and East Jones Avenue. This project will assist in restoring this tributary to a natural state, including planting more native vegetation to improve aesthetics and reduce maintenance. The City contracted with Goodwyn Mills Cawood for design services for the project.

Budget Impact: The bid amount of \$354,414.20 is below the grant amount of \$381,715.00. The grant funding will fund the project construction. The city has met its grant match responsibilities during the design of the project.

Darren Prather,

MGPE is giving a bid for the Little Lotts Tributary Stream Restoration Project. We will be providing the necessary equipment, workforce, and material as listed in the bid table to restore approximately 1,000 LF segment of the Little Lotts and build Creek Tributary along the blind Willie McTell Trail, and between East Grady St. and East Jones Ave. This area is approximately 1,000 LF of stream restoration, and 1.2 acres of flood plain and stream build. We will keep all work and material within the LOD, any areas that MGPE disturbed will be returned to preexisting and/or better condition by the completion of the project.

\$ 354,414.20

Scope of Work:

1. *Creating a new Bioswale*
2. *The First 499 LF of stream we will just install structures and remove the vegetation needed to install the structure.*
3. *Demo a small concrete pad blocking the new Bioswale.*
4. *Installation of two construction entrances and staging areas as needed.*
5. *Installation of a pump and check dam for pump around while working in the stream.*
6. *The second section of the stream build is approximately 520 LF and will require a full stream build with structures, flood plain, and an Offline Detention area.*
7. *Live stakes, temporary and permanent seeding. This is per the bid table.*
8. *Mobilization, moving equipment, supplies, installation of the two construction entrances, and moving crew to the Job.*

Assumption's:

- *2/10th accuracy vertical and horizontal*
- *All material quantity is based on the provided quantity and type listed in the bid table.*
- *Materials bought and stored on-site will be billed along with the normal pay request.*
- *Ground control provided*
- *GPS files provided for GPS site controls.*
- *Invoices will be paid on a net 30 basis.*

Exclusions:

- Contractor shall promptly, give a written notice to owners on encountering unforeseeable conditions, like rock, ground conditions, extreme weather conditions, and/or delays caused by other contractors and/or property owners that may adversely affect the work. Owners shall investigate the site conditions promptly after receiving notice. If the conditions cause an increase in cost to contractor or the time needed for performing any part of the work and were not reasonably foreseeable by an experienced contractor, a fair adjustment shall be made under this clause and the contract modified in writing accordingly.
- Material overages
- Construction barriers
- Special ground and/or Bank stabilization along the the edge of the building located on the south end of the stream build.
- Pulling permits from the Railroad for working near the rails
- Erosion, and/or water drainage problems from plugging an existing culvert.
- Installation of any RCP culverts
- Hauling off trash and/or debris left by others.

This bid is good for 30 days from the date listed above.
