Mr. Penny announced that a joint meeting with the Bulloch County Commissioners has been set for November 29th at 2:30 pm to talk about infrastructure. The location has not been set and will be announced at a later time.

Wayne Alexander asked where we are on the zoning changes for tiny homes and where are we on the situation of the homeless?

Councilmember Phil Boyum stated that the city is currently working on revising the entire zoning code and tiny homes is certainly something that can be addressed.

Mayor Jonathan McCollar stated about five years ago the poverty rate was at 50%, currently we are at about 42%, so we are seeing it go down but this is a long term fight and takes time. With the growth that is coming to our area we need to find more strategic ways to address homelessness.

Councilmember Paulette Chavers stated that this is the second meeting in a row that someone has brought up homelessness and we need to be taking steps now to get ahead of the game. In addition the need to address homelessness is something I've been echoing since I got on council.

Mayor Jonathan McCollar spoke on his thoughts regarding the violence problems in our county and his concern about the normalization of bad behavior. We have got to do better we are in this community together and we can do better.

Ordinance 2022- 08:

An Ordinance Amending Article 2 (Authorities, Boards and Commissions) of Chapter 2 (Administration) of the Statesboro Code of Ordinances

WHEREAS, the City has previously adopted ordinances creating certain Authorities, Boards and Commissions; and

WHEREAS, the Mayor and City Council has determined there is sufficient reason and need to amend certain sections of Article 2 (Authorities, Boards and Commissions) of Chapter 2 (Administration) of the Code of Ordinances, City of Statesboro, Georgia to create the Statesboro Business Commission

NOW THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Statesboro, Georgia, in regular session assembled as follows:

SECTION 1:

Article 2 (Authorities, Boards and Commissions) of Chapter 2 (Administration) of the Code of Ordinances, City of Statesboro, Georgia is hereby amended to read as follows:

Sec. 2-85 Establishment; appointment; terms; compensation; removal.

Sec. 2-86 Chairman; rules of procedure and bylaws; meetings.

Sec. 2-87 Scope of Authority.

Sec. 2-85. - Establishment; appointment; terms; compensation; removal.

There is hereby created a board to be known as the Statesboro Business Commission. The Statesboro Business Commission shall consist of seven (7) members who shall be authorized representatives of an entity holding an occupational tax certificate with the City of Statesboro. The initial term of office of four designated members shall be two years with the initial terms of the other three members being one year, beginning on January 1st and ending at the stroke of midnight on December 31st. Successor members shall be appointed by the Mayor and City Council for a term of two years. Statesboro-Bulloch Chamber of Commerce shall have option of recommending to Mayor and Council one qualified person from their membership to one of the one year initial terms and any successive appointments for that position. Vacancies on the Statesboro Business Commission occurring other than by expiration of term shall be filled by an interim appointment for the unexpired term by the Mayor and City Council. The Mayor and City Council shall have the authority to remove any member of the Statesboro Business Commission by a majority vote for cause, on written charges, after a public hearing. All members shall serve without compensation.

Sec. 2-86. - Chairman; rules of procedure and bylaws; meetings; records.

a. The Commission shall elect a chairman from among its members who shall serve for a term of one year and who shall be eligible for re-election as chairman.

b. The Commission shall make its own bylaws and rules of procedure and shall determine its time and place of meetings.

c. The transactions of the Commission are governed by the Georgia Open Meetings Act O.C.G.A. §§ 50-14-1 et. seq., and it shall be the joint and several responsibility of the members to comply with the Georgia Open Meetings Act.

Sec. 2-87 — Scope of Authority.

The Commission shall have the authority to prepare studies and reports for the purpose of informing the governing body on policy matters related to the impact of local ordinances and procedures on business opportunities and operations within the municipal limits of the City of Statesboro.

SECTION 2: All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 3: This ordinance shall become effective immediately upon its adoption by the City Council.


The applicant requests a special exception to locate a massage therapy practice in the building on 0.52 acre property located on South Zetterower Avenue. Massage services are not permitted in the O (Office) zoning district unless granted a special exception by the City Council.



SUBJECT SITE

The subject site is a residential conversion building located on 0.52 acres. Surrounding properties include residential and office uses. The applicant's request is to locate a massage therapy practice.

The *City of Statesboro 2019 – 2029 Comprehensive Master Plan* designates the subject site as a part of the "Neighborhood Center", which is characterized by a blend of lower to medium density residential, commercial, personal service, and offices that are neighborhood scale in size and intensity.

ENVIRONMENTAL SITE ANALYSIS

The subject property does not contain wetlands and is not located in a special flood hazard area. Any potential issues will be brought forth and discussed during standard permitting and review procedures.

COMMUNITY FACILITIES AND TRANSPORTATION

The subject property is currently served by City utilities.

CONDITIONAL ZONING STANDARDS OF REVIEW

The *Statesboro Zoning Ordinance* permits the grant of conditional zoning upon a finding by the governing body that the requested use is "of the same general character" as those uses permitted within the district without the grant of a special exception and requires that "in determining the compatibility of the conditional use with adjacent properties and the overall community, the Mayor and City Council (will) consider the same criteria and guidelines [as for] determinations of amendments, as well as the following factors".

Article XXIV, Section 2406 of the *Statesboro Zoning Ordinance* lists **seven (7) factors** that should be considered by the Mayor and City Council "in determining the compatibility" of the requested use with adjacent properties and the overall community for considerations of Conditional Use Variances, or Special Exceptions as follows:

(A) Adequate provision is made by the applicant to reduce any adverse environmental impact of the proposed use to an acceptable level.

- The business would be located inside the pre-existing structure.
- (B) Vehicular traffic and pedestrian movement on adjacent streets will not be substantially hindered or endangered.
 - There should be no substantial change regarding this facility if allowed to operate, as the area already allows for parking and pedestrian traffic.
- (C) Off-street parking and loading, and the entrances to and exits from such parking and loading, will be adequate in terms of location, amount, and design to serve the use.
 - The location has a large area in the rear of the building to allow for parking.
- (D)Public facilities and utilities are capable of adequately serving the proposed use.

- Public utilities are available in the area, and it is unlikely to cause any significant changes to the area.
- (E) The proposed use will not have significant adverse effect on the level of property values or the general character of the area.
 - No adverse effect is expected.
- (F) Unless otherwise noted, the site plan submitted in support of an approved conditional use shall be considered part of the approval and must be followed.
 - There is no site plan required for this building as the space already exists and currently has an active business at the location.
- (G) Approval of a proposed use by the Mayor and City Council does not constitute [an] approval for future expansion of or additions or changes to the initially approved operation. Any future phases or changes that are considered significant by the Planning Commission and not included in the original approval are subject to the provisions of this section and the review of new detailed plans and reports for said alterations by the governing authority.
 - Any significant future structural changes to this proposal must first be reviewed and approved by Staff.

Article XVIII, Section 1802 of the *Statesboro Zoning Ordinance* further outlines the qualifications needed to grant a special exception to the zoning ordinance. These include uses that are consistent with the purpose and intent of the zoning ordinance and district in which the use is proposed to be located; uses that do not detract from neighboring property; and uses that are consistent with other uses in the area. In order to meet these qualifications, approval of any special exception for the proposed use at the subject parcel should (if necessary) include conditions that will ensure that development along this corridor remains consistent with the *Statesboro Comprehensive Plan* and the *Statesboro Zoning Ordinance* and that serve to mitigate negative effects of the use to the surrounding area's character, uses, and zones.



 - Preliminary plans do show sufficient parking, but specifics for entryways would be determined during the development.

- (E) The proposed use will not have significant adverse effect on the level of property values or the general character of the area.
 - No adverse effect is expected on surrounding commercial properties. The nature trail next to the property might be affected.
- (F) Unless otherwise noted, the site plan submitted in support of an approved conditional use shall be considered part of the approval and must be followed.
 - There is a preliminary site plan included in the document.

RE: City of Statesboro - Speed Limit Ordinance List of Roads (LOR)

Policy Issue: Ordinance

Recommendation: Attached for Mayor and City Council's consideration and adoption is the 2019 List of Roads (LOR) with City Street Speed Limits recommended by the City Public Works and Engineering Department and approved by Georgia Department of Transportation (GDOT).

Background: Engineering works with GDOT and the City Police Department (SPD) to update the current speed limit list for Statesboro's streets and roads. The adoption of the 2022 List of City Streets Speed Limits is a recurring process for the City of Statesboro, with the goal of being certified to use SDDs to enforce speed limits within the city limits.

The next step in accordance with GDOT Policy 6780-4- Establishment of Speed Zones is adoption of the LOR as an ordinance by the Mayor and City Council.

Adoption of this document by Mayor and City Council is one of the steps required by the state to allow the use of approved speed detection devices (SDD) (e.g. radar or laser detectors) to enforce city and state speed limits inside Statesboro's city limits. This process is repeated every three years or when speed changes occur within the city limits. After the document has been adopted by City Council and signed by the Mayor, the document will be returned to GDOT for documentation and filing.

The entire process will culminate with the Georgia Department of Public Safety (DPS) issuing the City of Statesboro a SDD Certificate that allows us to use approved SDDs to enforce speeds for a period of three years. The City of Statesboro has a DPS issued SDD Certificate that expires December 31, 2022.

RE: Emergency repairs to sewer main on Tillman St.

Policy Issue: Purchasing

Recommendation: Consideration of a motion to approve payment to Y-Delta Inc. in the amount of \$36,367.79 for repairs to sewer main on Tillman St. with funds from system operating revenues.

Background: On the morning of August 24th we received a call of sewer backing up in the Collage St. and Vista Circle area. When crews arrived on scene it was determined that the sewer main was plugged just North of the intersection of Tillman St. and South Main adjacent to the Gnats Landing property. Crews attempted to clear the line with a sewer Jet Vac truck, but were unsuccessful even after several attempts. Because the plugged main was deep, in a dangerous location and threatening to flood nearby houses, it was decided at that point to call in an outside contractor to excavate the main and make the repairs. Y-Delta Inc. was working on another City project and we contacted them to see if they could assist and they agreed to come right away. The main was exposed and it was found that it had been damaged by a contractor installing a service line for Vyve Broadband. Over the course of 48 hours the main was repaired, the service reinstalled, the hole backfilled and the road repaired, with no damage to the surrounding homes and businesses.

Budget Impact: Repairs will be paid for with funds from Operating Revenues to be refunded when the insurance claim is settled.



Policy Issue: Purchasing

Recommendation: Consideration of a motion to award a contract to C&H Pipeline Inc. in the amount of \$366,413.39 for the installation of 3800' of 6" steel gas main at the Gateway Industrial park to serve Aspen Aerogels. To be paid for with funds approved in the FY2023 CIP Budget item #NGD-99, with approval to spend up to \$420,000.00.

Background: As part of the agreement between the City, Bulloch County Development Authority and Aspen Aerogels, the city agreed to extend the existing high pressure gas main approximately 3800' to a mutually agreed upon location on the Aspen property. This extension will also makes gas available to the last remaining large lot in the park. The project was formally bid and three qualified bids were received. Our consultants at Sapp Engineering have reviewed all of the bids and have provided a written recommendation to award the contract to C&H Pipeline Inc.

Their bid of \$366,413.39 is slightly above our budget of \$350,000.00 but in the current economic environment it was anticipated that the project would come in close to \$400,000.00. We are requesting a total budget of \$420,000.00 to cover the cost of engineering fees and provide a small amount for contingencies.

Budget Impact: CIP Project NGD-99 was approved in the 2022 Budget to be funded from Operating Revenue with funding at \$350,000.00. We are requesting a budget of \$420,000.00 with the additional \$70,000.00 also coming from Operating Revenues.

Policy Issue: Purchasing

Recommendation: Consideration of a motion to award a contract to Vortex Services, LLC in the amount of \$797,065.00 to rehabilitate approximately 14000' of sewer main. This project was funded as part of the 2023 CIP Budget, Item #WWD14, with funds from the 2019 SPLOST with the approval to spend up to \$850,000.00.

Background: As part of the City's ongoing efforts to reduce ground water infiltration into its sanitary sewer system we are proposing to line approximately 14000" of sanitary sewer main with Cured In Place liners. Our Wastewater Treatment Plant experiences extremely high flows during rain events and period of wet weather. Reducing this flow will extend the life of the plant and free up capacity for other uses while reducing operational costs.

Competitive bids were obtained from five qualified installers and were reviewed by our consultants at Hussy Gay Bell Engineering. A low bid of \$797,065.00 was submitted by Vortex Services, LLC; just below our budget of \$800,000.00. However we are asking for a total budget of \$850,000.00 in order to add an additional 500' of lining to upgrade a section of sewer crossing the Blue Mile Project at Tillman St. Of the five bids received none of the bidders were able to meet the 20% MFBE. Sewer Lining requires the use of proprietary products that are sole source from one supplier, this makes it difficult for contractors to meet the requirement. The bid submitted by Vortex Services has an 8.2% MFBE participation obtained by the use of MFBE subcontractor to perform video inspection and cleaning services.

Budget Impact: Funds were approved as part of the 2023 CIP Budget with funds coming from the 2019 SPLOST. The additional \$50,000.00 will also come from 2019 SPLOST funds.
